**TO ALL BIDDERS:**

Pursuant to **Section 1.5e** in relation to **Section 10.1.d** and **Section 10.1.e** of the **Instructions to Bidders (ITB)** of the Bidding Documents for the NAIA-PPP Project (“Project”), the PBAC is issuing this Bid Bulletin to announce, as follows:

1. After a full and detailed evaluation of the Technical Proposals submitted last 27 December 2023 in accordance with Section 10.1.f (in relation to Section 3.1 and Section 5.1) of the ITB, the PBAC has determined that the following Qualified Bidders submitted Technical Proposals that have been rated as Complying:
  - a. Manila International Airport Consortium
  - b. GMR Airports Consortium
  - c. SMC SAP & Company Consortium

Accordingly, pursuant to Section 10.1.g of the ITB, the PBAC is issuing the Notice of Compliance / Non-Compliance to the Bidders regarding the results of the evaluation of their Technical Proposals submitted 27 December 2023.

2. As stated in Section 10.2.a of the ITB, only the above-named Qualified Bidders with Complying Technical Proposals are allowed to attend the **Opening of the Financial Proposals**. The Opening of the Financial Proposals shall be held at **10:00 a.m. on 08 February 2024** at **the OSEC Board Room, 9th Floor, Primex Tower, EDSA corner Connecticut Street, San Juan City, Metro Manila, Philippines 1503**, and through Google Meet at <https://bit.ly/PBAC-08FEB2024>, which shall be open to the Bidder’s representatives. The Opening of the Third Envelope (Financial Proposals) can also be viewed via Facebook Live at DOTr’s official Facebook Page at Department of Transportation-Philippines (@DOTrPH)
3. A maximum of eight (8) representatives shall be allowed per Bidder to attend in-person the Opening of the Third Envelope (Financial Proposals), whose names and official designations are to be relayed and communicated until **06:00 a.m. of 08 February 2024** to the PBAC (email address: [proc-bsd@dotr.gov.ph](mailto:proc-bsd@dotr.gov.ph)). The names and official designations of the representatives who will be attending the Opening of the Third Envelope will also be provided to the Administrative Service, DOTr Security, and Primex Management, for purposes of validating their valid IDs (e.g., company ID, passport, driver's license, etc) upon arrival onsite. A Bidder who does not send representatives to witness the proceedings on Opening of the Third Envelope (Financial Proposals) shall be deemed to have waived the opportunity to witness the said proceedings.

All supplemental notices and bid bulletins issued by the PBAC shall be deemed part of the ITB and incorporated in and made an integral part of the relevant Bidding Document.
